Dear Parent or Guardian,

We are pleased to announce the resumption of our in-person education programming at our Winchester and Richmond day school programs beginning March 1! In certain areas the resumption of in-person will be a staggered process with certain groups coming first, followed shortly by others. Your case manager will provide details. As detailed in the guidance, it is important that we ensure excellent communication between the home and the school. Your assigned case manager is your primary contact inside of Grafton.

Please take a moment to review the attached screening form – this will need to be sent with your child each day. Screening is an essential way to stay free of the virus in our schools. Please take this responsibility very seriously, and know that we will also be screening all students at the door. Any student without a completed home screening form will be sent home immediately via the transportation that brought them to the program. Any child found to have a fever or any symptoms of Covid-19 will similarly be returned home immediately via the transportation that brought them to the program.

We ask that you maintain a safe environment in your home by limiting visitors, not traveling, and maintaining high vigilance for any symptoms experienced by any family member. As a reminder, if there should be any Covid-19 direct exposure in the home, it must be reported to your child's case manager immediately.

We are looking forward to greeting your child at our schools, and resuming in –person learning. Your compliance with these protocols will help us ensure that we do not need to interrupt in-person learning again at Grafton. Vaccinations have been offered to our staff, and a large group has opted to receive it. That being said, the vaccine is not available to children at this point and we must ensure their safety by continuing the screening process that has been in place since March.
